



FIM ENTRY CHECKLIST.

This checklist is designed to assist in the process to ensure all the appropriate paperwork is submitted.

This checklist applies to USA residents only.

FIM entries consist of 3 parts: (a) BMST Entry form, (b) FIM Licensing application, (c) FIM World Record Application form

PLEASE READ THE CHECKLIST- SOME PROCEDURES HAVE CHANGED FROM EARLIER YEARS

- READ the FIM rule book <https://www.fim-moto.com/en/sports/view/fim-land-speed-record-4357> or via bonnevillemst.com in the rules and records page. It is your responsibility to read and understand the rules.

- (A) Complete BMST Entry Form online. <https://bonnevillemst.com/entry/registration-tickets/>
 - Select event: FIM World Records Registration
 - Submit entry **NO LATER than July 15th 2021.** (Late fee applies from July 16th and FIM entry will not be guaranteed for late entries).
 - *A separate entry must accompany each motorcycle and/or rider and/or class

- (B) Complete FIM license application forms
 - Complete *2021 FIM LICENSE APP FORM_Bonneville*
 - Sign *AMA ANNUAL ADULT RELEASE (digital waiver)*
 - Complete FIM *MEDICAL HISTORY & EXAMINATION* forms- One page **MUST** be completed by your doctor. NB: Exercise EKG may be required. Results are valid for 3 years see page 8 rule 09.1.C Medical Code)
 - Read [FIM ANTI-DOPING CODE](#). The document is available online. Sign *APPENDIX 3- Consent Form (digital waiver link on BMST FIM page)*
 - Make payment payable to AMA** (license fee \$350, + AMA renewal if applicable)

- (C) Complete *WORLD RECORD ATTEMPT APPLICATION* form
 - Rider must sign the form- your license number will be added by the AMA.
 - Include with your application:
 - Photos certifying the condition of the machine (2 photos with fairing and 2 without fairings), the effectiveness of the safety points (photos of each point). Digital format required (CD or email). Please use hi-res 500kb or larger to ensure that the bike can be seen.
 - All machines must provide photos- even if it has participated before in the same configuration.

- Submit both (B) forms and (C) forms to the AMA **NO LATER than July 19th 2021.** SUBMIT ASAP to ensure it is complete. If not received by July 20th we cannot guarantee that it will arrive at the FIM by their 30 day deadline. Mail to:
